

**NBSRT SAINT JOHN  
EXECUTIVE COMMITTEE MEETING  
March 15<sup>th</sup>, 2012**

This meeting was held at Chateau Champlain at 10 AM with President Marg Urquhart chairing and the following in attendance: Robert Taylor, Carol Harris, Larry McPhee, Sue Smith, Barry Harbinson, Nancy Steele, Linda Perrin, Jean Cameron, Pat Dugay, Mary Ellen Maillet, Mary Ann Patterson. Regrets were received from Pat Beyea, Barrie Rigby, Norma Murphy, Gerry Mabey and Patricia Roy.

**Agenda:** Larry **moved** approval and Barry **seconded**; motion **carried**.

**Minutes** of the February 2<sup>nd</sup> meeting: Several corrections were noted:

- Membership (first line): Mary Ellen Maillet, not Mary Ann Maillet;
- NBTA Pension Seminar: Delete the title and move the sentence to the end of the Membership report, adding that Netta Chase volunteered to design such a poster.
- Awards: typo “next”.

**Moved** by Barry and **seconded** by Mary Ellen that the Minutes be approved as corrected; motion **carried**.

**Financial Report:** Larry circulated a listing of the assets of the Branch, totaling \$17,501.19. He noted that we are receiving a rebate of \$1440 for 480 members, but we are missing out on rebates for 26 other members. He reported he received a thank-you letter from the Seniors Centre in the City Market for our donation. It was recommended that budget requests for 2012-13 be given to Larry by March 31<sup>st</sup> so that the Finance Committee can meet to prepare a proposed budget to recommend to the April Executive Committee meeting. The following motions were made:

- **Moved** by Barry and **seconded** by Nancy that the Social Committee budget for 2011-12 be increased to \$1500; motion **carried**.
- **Moved** by Larry and **seconded** by Jean that the financial report be accepted; motion **carried**.
- **Moved** by Pat Dugay and **seconded** by Robert that \$5000 from the current account be invested in a five-year Step GIC at Bayview Credit Union (average 2.75% rate); motion **carried**.

**Membership Follow-up:** Carol Harris and Pat Dugay reported that they made some phone calls, and many said if they were automatic members of NBTA then they took it for granted they were automatic members of NBSRT. Marg reported that District Office has agreed to make a letter and enrolment form available to retirees. The Provincial NBSRT is seeking to have Districts allow retiring teachers sign a waiver to allow District offices to release their contact information to NBSRT Branches. It was suggested that Branches might confer with each other to see if others are having “contact information” and “border” issues.

**3<sup>rd</sup> Annual Newsletter?:** Robert reported that George Little would find compiling this in January to be tight, as he and Pearl are normally getting ready to go away. It was **moved** by Larry and **seconded** by Jean that we start a 3<sup>rd</sup> issue as a winter “contact bulletin” with a focus on Branch activities, to be sent out by January 31<sup>st</sup>; motion **carried**. Barry and Robert offered to help with compiling.

**River Boat and School Days Museum Trips:** An indication of interest was sought at the February card party, and sign-up sheets will be available at the May luncheon.

**Social Committee Report:**

- Card Party was very successful, with 58 people including some friends of members, great food and prizes. It was duly noted that the only man present (Larry) won the 50/50 draw!
