#### **Minutes**

**Minutes:** moved by Carol Raynes and 2<sup>nd</sup> by Judy Braman –carried. Carol expressed her gratitude for all the warm wishes offered to her and her husband on their recent marriage.

### **Treasurer's Report:**

Robert Taylor provided a financial report.

The October Luncheon showed a net loss of \$316.00. The branch agreed to subsidize the rental and this resulted in the loss.

The November card party showed a loss of \$141.00. This event is considered to be a service to the members and break even is not expected.

The Christmas Wine and Cheese Party showed a net loss of \$429.00 however there are still outstanding receipts from those who did not attend but committed to attendance in their follow up phone call.

A discussion ensued regarding collecting from those 'no shows' especially for costly events like the dinners. It was decided that a note in the newsletter would remind people of the expenditures resulting from their commitment and the resulting losses from non-payment. AGM financial report will indicated losses from non payments.

The investment portfolio remains unchanged.

Robert Taylor moved, 2nded by Judy Braman to accept the financial report as submitted. Motion carried.

#### **Pension Committee report:**

John Sinclair, CEO of Investment Management reported that the plan did very well with without the money from the province. It increased by 300 000 000 +; it is well over last year.

What is the real issue promoting shared risk? Actuarial tables show a billion dollar loss in future and the shared risk choice would take this 'paper debt' from the books.

There was a meeting with NBTF, NBSRT president, SERV- 3 members, and Dawson Murray. Questions are being asked on Appendix B especially the definition regarding language e.g. retirement age. Is the concept of age service index gone? Do we want teachers in the classroom until age 65? The NBTF says no; the government says no; and the teachers say no. Smaller meetings are scheduled to hammer out language etc. Alward recognizes the difference between PSSA and NBTF pension plans. Higgs will not entertain delay tactics that would delay legislation before spring. It is difficult to say what legislation will look like. The government speaks of 'intergenerational' fairness and the need to be 'fair' to next generation of teachers.

Higgs stated that current benefits could and would be protected but nothing in the legislation protects this.
