Pension Committee:

1. Barry presented a flyer indicating active teachers would be meeting at Centennial School on March 25th and marching to Trevor Holder's office around 4:50.

Questions around the table: why are we marching?

Comments: There needs to be large numbers or media will indicate lack of interest by teachers. Is the concern for teachers teaching to 65 or losing 5% per year early? Are there survivor benefits? There is concern for young teachers who will be hit hardest.

2. Marilyn and Larry's presentation at Barry's. Outstanding unknown issue what is the guaranteed proposed fix number for indexing/cost of living? Marg indicated that compounding could occur.

There is no real information yet on what is in the proposal or a specific indexing number. The issue that active teachers didn't support teachers on group insurance is still stinging and there is an undercurrent of retired who wonder if we should be falling in line with their fight? Generally, there seems to be a consensus that we will take a hit to help active teachers who could lose as much as 35% of possible pension.

3. All teachers fall under the Teachers' Pension Act and NBSRT can join in the discussion but have no official voice. There is nothing on record that allows retired teachers a vote to accept or reject. If proposal (by NBTF) is damaging to retired teachers what recourse do we have? Who is representing us and are they (the Board) going to rubber stamp whatever the proposal is? It appears the provincial NBSRT is not showing the desired leadership on this issue. We do not have legal representation. What is the protocol when the Government accepts or rejects the Federation's proposal?

We need strategies in place for the various scenarios.

MOTION: Moved by Marg and seconded by Ellen that: A letter be sent to Roger Nesbitt with a copy to the Board stating that the Saint John Branch feels strongly that there is a need for a meeting to discuss planning various strategies based on the proposal's acceptance or rejection. **Carried.
