PREMIUM SCHEDULE SUMMARY 2013

A November, 2012 communiqué from the NBTF Group Insurance Trustees informed the members that:

Dental Coverage (Optional): 9.1 %increase

Health & Drug Coverage: average of tiers 14.0 % increase

RECOMMENDATIONS/ACTIONS by NBSRT Group Insurance Committee

The committee met January 15, 2013 to discuss the Communique sent out by the NBTF Group Insurance Trustees on November 23, 2012 outlining the renewal and Group Insurance Rates for 2013. This meeting resulted from the expression of concerns by several members regarding the huge change in the physiotherapy limit. The level of concern prompted us to further request a meeting with the Executive Officers of the NBSRT. This took place January 25, 2013.

The committee requested a letter be sent to the Trustees asking they reconsider their decision to remove the physiotherapy limit from "unlimited" to a cap of \$600. The NBSRT Executive Officers sent this letter to Marilyn Boudreau, the Liasion person for the NBTF Trustees on Jan. 28, 2013. A request was also made asking that more effort be made to get the members booklet published. The NBSRT President Roger Nesbitt will also be taking these issues to a meeting of the NBSRT-SERFNB Liaison Committee when it meets in May. The committee is currently waiting for a response to the letter from the NBTF.

The committee is advising the membership to express their personal concerns to the Trustees by contacting Marilyn Boudreau, the NBTF Liaison person for the retired teachers, as well as Johnsons Insurance Chief Executive Officer Dale Weldon. Also, they may contact the retired teacher's trustee Callum McPhee. Contact information can be found at the top of the homepage for this website.
